ADDENDUM

This transfer is the second of two transfers of replacement property as part of a "reverse like-kind exchange" under Section 1031 of the Internal Revenue Code. The Real Property Entity and the transferor of the controlling interest reported herein have acted solely as agents of Washington Real Estate Investment Trust (WRIT) in order to facilitate that 1031 exchange.
